

# Dissertation Seminar Consulting Project

Academic Year: 2017/2018

## Seminar Description:

This course aims to help students doing their consulting project and writing their master thesis. It comprises a group of mandatory sessions that will help guiding students in their consulting project and it will provide an overview of research methodologies, offering students the main skills to write up a project.

Groups of two students work together on a given Consulting Project for the whole duration of the workshop, in direct contact with the client organization and pursuing their own project. However, each student needs to make an individual problem statement, literature review and write an individual master thesis.

Students are advised to do this dissertation as a full-time job. It is possible that students may spend 1 or 2 days a week working in client site.

#### Seminar Content:

In each session, students will be given a list of tasks that need to be fulfilled until next session. All sessions are mandatory. Due-dates are non-negotiable. In sign-up for this workshop, each participant commits to meet the proposed deadlines.
